

## **Official Rules**

### **Wizards' Magic: The Gathering Pro Tour M15 Garruk Live Art Battle Drawing**

By entering the Wizards of the Coast LLC ("Wizards") Live Art Drawing to win one limited edition art prize at the Magic: The Gathering Pro Tour M15 event (the "The Sweepstakes") you ("You" and/or "Entrant") agree to be bound by these Official Rules.

YOU ARE NOT REQUIRED TO MAKE A PURCHASE TO ENTER OR TO WIN.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

**1. Eligibility:** The Sweepstakes is open to all attendees of the event. Employees of Wizards, its affiliates, and immediate family members of such employees and members of the same household (related or not) are not eligible to participate in the Sweepstakes. The Sweepstakes begins at 10:00 a.m. Pacific Time ("PT") on August 1<sup>st</sup>, 2014 and ends at 2:30 p.m. PT on August 3<sup>rd</sup>, 2014. The Sweepstakes is sponsored by Wizards. If an entrant wins a prize, then he or she is ineligible to win again. Entrants must be present to win.

**2. How to enter:** To enter, you must pick up an entry ticket. Entry tickets may be obtained by stopping at the Event Host desk at the Pro Tour venue and requesting a ticket from the Event staff from Friday, August 1 at 10:00am until Sunday, August 3 at 2:30pm. Entrants may submit one entry ticket per hour during the hours of 10:00am- 6:00pm, August 1, 10:00am- 6:00pm, August 2, and 10:00am- 2:30pm, August 3. All entries become the exclusive property of Wizards and will not be acknowledged.

**3. Winner Selection:** Ten winners will be determined by tickets drawn from the pool at the Magic: The Gathering Pro Tour M15 event. Entrants must be present to win. Should the first number drawn not be present, numbers will be drawn until a winning ticket is presented. There will be one drawing during which ten entries will be drawn. The drawing will be held on August 3 at 3:00 pm local time. Each of the ten winners must be present to win.

The prize will be delivered to each winner after the event. Each winner must provide a current shipping address and contact phone number in order to complete delivery.

Approximate value of each prize is \$30.00.

Prizes are not transferable, assignable, or redeemable for cash. No extensions will be permitted. Wizards, in its sole discretion, may substitute a prize for product(s) of equal value to the prize or provide the cash equivalent. Each winner is solely responsible for paying all applicable federal, state and local taxes, and all other expenses associated with any prize not explicitly stated herein. Wizards is not responsible for the winners' travel to the Magic: The Gathering Pro Tour M15 event location or for any costs for lodging, expenses, etc. related thereto.
