



CONFIDENTIAL PLAYTEST AGREEMENT

PLEASE READ THIS CONFIDENTIAL PLAYTEST AGREEMENT (THE "**AGREEMENT**") CAREFULLY AND IN ITS ENTIRETY. THIS IS A LEGAL AGREEMENT BETWEEN YOU AND WIZARDS OF THE COAST LLC ("**WIZARDS**") AND GOVERNS YOUR PARTICIPATION IN A **CLOSED AND CONFIDENTIAL** PLAYTEST (THE "**PLAYTEST**").

BY CLICKING "I ACCEPT," AND/OR PARTICIPATING IN THE PLAYTEST YOU (A) ACKNOWLEDGE THAT YOU HAVE READ THIS AGREEMENT IN ITS ENTIRETY, (B) AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS, AND (C) ARE AUTHORIZED AND ABLE TO ACCEPT THIS AGREEMENT.

Playtest. As part of your participation in the Playtest, you may download, install, play, and otherwise access a nonpublic and confidential version of this Wizards digital game (the "**Game**"). During the Playtest, Wizards grants you a limited, personal, nonassignable, nonexclusive, nontransferable license to use the Game solely for the purposes of the Playtest, to provide Feedback and participate in Playtest forums. Use of the Game, forums, or any other materials provided to you as part of the Playtest not expressly permitted under this Agreement is strictly prohibited.

Feedback. As part of the Playtest, you may provide Wizards with comments, feedback, thoughts, questions, ideas, and suggestions regarding the Game ("**Feedback**"). You are solely responsible for all Feedback you provide and you acknowledge that such Feedback will not violate the intellectual property rights of any third party.

Ownership. Wizards owns all right, title, and interest in and to (a) the ideas, concepts, brands, and products arising from the Playtest, (b) the Game, (c) all related and underlying intellectual property including all trademarks, patents, and copyrights in the Game, and (d) all derivatives of the foregoing as defined by the Copyright Act (17 U.S.C. §101) and applicable case law. Additionally, all Feedback submitted by you to Wizards is deemed a work-made-for hire as defined in the Copyright Act (17 U.S.C. §201) and is owned by Wizards. To the extent necessary, you hereby convey, transfer, and assign all rights in and to the same to Wizards and disclaim any and all proprietary and moral rights. You agree to execute documents and take further actions as requested by Wizards to assist in validating, effectuating, maintaining, protecting, enforcing, perfecting, recording, patenting, or registering its rights. If you are unavailable, or fail to execute such documents when requested to do so for any reason, Wizards may execute the aforementioned documents as your attorney-in-fact, which appointment will be irrevocable for this sole purpose.

Automatic Game Communications and Monitoring. Playing the Game requires an Internet connection to Wizards' servers. As part of playing the Game, you explicitly consent to Wizards' collection of your hardware system profile data, internet connection data, gameplay data, location data, and any other data related to the operation of the Game. Wizards may automatically deploy or provide patches, updates, and modifications to the Game that must be installed to continue to play the Game. Wizards may update the Game remotely including, without limitation, the Game client residing on your machine, with or without your knowledge. You hereby expressly grant to Wizards your consent to deploy and apply such patches, updates, and modifications to the Game.

Confidentiality. This Playtest, the Game, material posted to forums, and any documentation related thereto are confidential and proprietary to Wizards ("**Confidential Information**"). You will maintain Confidential Information in the strictest of confidence and will not disclose it to any third party. Further, you agree not to copy, distribute (either in physical or digital format), publish, display, disseminate, release, or otherwise disclose Confidential Information, or create any derivative materials. You may play the Game only in your home or other non-public locations. You may not discuss this Playtest, content posted to forums, or your experience with the Game with parties not participating in the playtest. You acknowledge and agree that disclosure of Confidential Information will cause significant and irreparable harm to Wizards, the extent of which may be difficult to ascertain. Accordingly, Wizards is entitled to injunctive relief as well as all other legal remedies that may be available if you breach this Agreement.

DISCLAIMER; LIABILITY LIMITATIONS. THE GAME AND PLAYTEST ARE PROVIDED "AS IS" AND, TO THE MAXIMUM EXTENT ALLOWABLE UNDER LAW, WIZARDS DISCLAIMS ALL WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT. FURTHER, WIZARDS DOES NOT WARRANT THAT OPERATION OF THE GAME WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT THE GAME WILL WORK PROPERLY ON ALL DEVICES. WIZARDS WILL NOT BE LIABLE TO YOU FOR ANY PERSONAL INJURY, PROPERTY DAMAGE, LOST PROFITS, COST OF SUBSTITUTE GOODS, LOSS OF DATA OR ANY OTHER FORM OF DIRECT OR INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES FROM ANY CAUSES OF ACTION ARISING OUT OF OR RELATED TO THIS AGREEMENT, THE PLAYTEST, OR THE GAME, WHETHER ARISING IN TORT (INCLUDING NEGLIGENCE), CONTRACT, STRICT LIABILITY OR OTHERWISE, REGARDLESS OF WHETHER WIZARDS HAS BEEN ADVISED OF THE POSSIBILITY OF THOSE DAMAGES. IN NO EVENT WILL WIZARDS' TOTAL LIABILITY TO YOU FOR ALL DAMAGES EXCEED \$10. SOME JURISDICTIONS DO NOT ALLOW FOR CERTAIN LIMITATIONS OF LIABILITIES OR WARRANTIES, SO SOME OR ALL OF THE ABOVE EXCLUSIONS AND LIMITATIONS MAY NOT APPLY TO YOU.

Miscellaneous. This Agreement, the Playtest, the Game, and your interactions with Wizards related thereto shall be governed by laws of the State of Washington, without regard to its conflict of laws principles. You hereby consent to the exclusive jurisdiction and venue of the state and federal courts within King County, Washington. If any provision of this Agreement is held invalid or unenforceable, in whole or in part, that provision will be modified to the minimum extent necessary to make it valid and enforceable, and the validity and enforceability of all other provisions of this Agreement shall not be affected. This Agreement constitutes the entire agreement between the parties related to the subject matter hereof and supersedes all prior oral and written negotiations, commitments, and understandings of the parties.
